Set up can begin as early as 8:00 AM the day of the event. Vendors are responsible for securing their own merchandise and belongings. There is not any event insurance to cover these items and is the responsibility of the vendor to purchase.

All Food Vendors agree to only sell approved items in their vending space(s). Beverages are not allowed to be sold. Food vendors are responsible for following food safety guidelines, including, but not limited to, proper sanitation and temperature controls. Proper serving utensils should be used to avoid cross-contamination. Vending space(s) must be kept clear of any hazards.

Vehicles are not allowed to be parked behind vendor space. Vehicles must be removed from the vendor area after unloading. No pets are allowed at this event. Non-compliance with these guidelines may result in immediate expulsion.

The Food Vendor fee is **\$50.00**. This fee is nonrefundable. The event will be held rain or shine. The completed Vendor Application needs to be received by **June 12, 2009** for consideration.
