This application is **not** for product or food vendors. Services provided must be appropriate for a family event. Vending space(s) must be kept clear of any hazards. No pets are allowed at this event. Non-compliance with these guidelines may result in immediate expulsion.

There is not a charge for Service Vendors. Businesses **MUST** perform the free service onsite at the Community Impact Day & EXPO. Businesses that sell a service, but not offering the free service onsite at the Community Impact Day & EXPO must complete the EXPO Vendor Application and pay the associated fees. Non-Profit organizations vendor spaces can be informational and services do not have to be provided onsite during event.

The event will be held rain or shine. Each vendor space will include one (1) table and up to two (2) chairs. Vendors are to supply their own marketing materials. The completed Vendor Application needs to be received by **June 19, 2008** for consideration.
